RATES FOR METERED SERVICE

AVAILABILITY

These rates are available to all customers located on the mains of the Company for all purposes except fire service, subject to the RULES AND REGULATIONS of the WHITINSVILLE WATER COMPANY.

MONTHLY METER RATES

Charges for water sold monthly will be the sum of the Monthly Service Charge by meter size PLUS a volumetric charge as follows:

WHOLESALE WATER RATES FOR NORTHBRIDGE WATER DEPARTMENT

AVAILABILITY

These rates are available only to the Northbridge Water Department and such service shall be subject to the RULES AND REGULATIONS of the WHITINSVILLE WATER COMPANY in all regards.

RATES

Charges for water sold will be the sum of the Service Charge by meter size PLUS a volumetric charge based on the following rate per hundred cubic feet:

RATES FOR PRIVATE FIRE SERVICE

AVAILABILITY

These rates are available to customers located on the mains of the Company for Private Fire Service subject to the RULES AND REGULATIONS of the WHITINSVILLE WATER COMPANY. The total cost of installing fire service connections shall be borne by the customer.

For purposes of this tariff, the term fire protection valve shall mean and include either: a) any gate valve attached to any pipe that has the purpose of delivering water to one or more sprinkler heads; and/or b) any post indicator valve. For the purpose of this tariff, the Company does not include within the definition of fire protection valves the two main trunk valves located at the junction of Company mains and mains of The Shop at Whitinsville on Water Street and Douglas Road, respectively.

TERMS OF PAYMENT

The Company may render bills on monthly basis. The above rates are payable within forty-five (45) days of the date of the bill.

SPECIAL PROVISIONS

- (a) All water shall be used for fire protection purposes only.
- (b) The Company reserves the right, if water is used in violation of (a) above, to install a meter on the connection at any time which will meet the requirements of the fire insurance companies. In the event a meter is installed, the established meter rates, including both water and minimum charges, will apply in addition to the above rates for Private Fire Protection.
- (c) A charge will be made for each unauthorized use of private fire facilities for each event as specified in the Company's Rules and Regulations.
- (d) A charge will be made for each unauthorized use of a public fire hydrant as specified in the Company's Rules and Regulations.
